HELPFUL REGULATIONS SUMMARY

QUIET TIME

Quiet time in Carillon Beach is 10pm to 7am. Anyone under 18 years of age cannot be out in the community unless accompanied by an adult. Anyone underage out in the community during quiet time hours will be considered to be trespassing.

BEACHES

Please access the beach by using one of Carillon's eight private Walkovers located along Beachside Dr. Also, observe **ALL** Bay County and Carillon Beach Rules that are **Posted at Every Walkover**. See below some Regulations that are not on Signage:

- Camping is prohibited on the beach
- Tiki Torches are prohibited per the Turtle Ordinance
- Tents are NOT allowed. Canopies are allowed but cannot exceed 10'x10'. (Shade Canopies CANNOT contain advertising of any kind)
- Fireworks are **PROHIBITED** on Beaches as per FL Statute 791
- Campfires are permitted by **Bay County AND Carillon Beach Permit ONLY**

TOWELS/BEACH ACCESSORIES

Towels, beach accessories, swimsuits or similar items are not to be hung over the railings or displayed from the exterior of any dwelling.

PETS

- Bay County **DOES NOT ALLOW PETS ON THE BEACH**
- All Pets are required to be on a leash
- All Owners/Guests are responsible for proper disposal of pet waste. For your convenience, Pet Waste Stations are placed throughout the community

GARBAGE

- Garbage Pickup Days are Tues/Thurs/Sat starting at 7:00am
- Bulk Pickup is on Wednesdays / all bulk items should be placed in the gravel in front of homes.
- All garbage must be placed inside Carillon Beach approved cans by 7:30 am on pickup days.
- No household garbage should be placed out front of any home.
- Cleaning crews must have garbage in cans by 1:00pm on Saturdays only.
- Any/All waste produced by vendors at any given home must be removed by them.

USE OF DRONE AIRCRAFT

No Drone Aircraft shall be operated over Carillon property without HOA permission.

SIGNAGE

No sign, advertisement or notices of any type shall be erected or displayed in or on Carillon Beach property, nor on Private Residences.

RENTAL GOLF CARTS

- All drivers must have a valid driver's license
- Passengers on a cart cannot exceed number of seats on a cart
- All passengers must remain seated at all times
- Operation of Carts restricted to streets ONLY
- Golf Carts are to be operated inside Carillon Beach Gates ONLY
- Speed limits and stop signs MUST be obeyed
- All golf cart rentals must come from **Coastal Cars & Carts**, which is the EXCLUSIVE vendor in Carillon Beach
